<b>Bill Summary:</b> This bill will impose an income tax on certain corporations within the state. Most of these corporations pay the income tax to the state in which they are incorporated because Wyoming does not collect the tax. This will generate \$45 million a year, and is currently earmarked for schools.

<b>Bill Summary:</b> This bill will increase lodging tax across the state. The revenue generated from this tax will be appropriated to the Wyoming Tourism Board; approximately 85% of the revenue generated from this tax will be paid by non-residents of Wyoming. This will enable the Tourism Board to no longer need operating money from the general fund, which frees up money for other state needs, including education.

<b>Bill Summary:</b>	Taxes on gasoline and diesel fuel will be indexed to inflation, meaning the taxes charged per gallon will fluctuate with inflation and deflation. Currently, 24 cents per gallon is charged on gasoline. That tax has not changed in several years, but the buying power of the 24 cents has decreased. By indexing fuel taxes to inflation rates, the revenue generated from the index will maintain its buying power through inflationary times.

**Description:** AN ACT relating to school finance; providing additional mills for school funding as specified; and providing for an effective date.

**Bill Summary:** When fully implemented (as drafted), this will generate \$100 million a year for public schools. This bill is designed to increase property taxes by 3 mills a year for the next three years, then remain at a total increase of 9 mills. For the median home of \$200,000, this would be an additional \$171 per year, or \$14.25 a month.
