<b>Title</b> Government Bailout Prevention Act	<b>Bill Summary:</b> Last edited by TFG Reports at May 11, 2020, 2:37 PM The bill would prohibit the use of federal tax dollars by insolvent state, territory, and local governments to bail out and pay off their obligations.
<b>Description</b> Government Bailout Prevention Act This bill prohibits the use of federal funds to purchase or guarantee obligations of, issue lines of credit to, or provide grants to any state (defined to include the District of Columbia and any U.S. territory or possession), municipal, local, or county government that, on or after January 1, 2019, has defaulted on its obligations, is at risk of defaulting, or has filed for bankruptcy. The Department of the Treasury is prohibited from using general fund revenues or borrowed funds to purchase or guarantee any asset or obligation of any such state, municipal, local, or county government. Emergency Relief for State, Territorial and Local Governments Act of 2020

#### Description

Emergency Relief for State, Territorial and Local Governments Act of 2020 This bill requires the Federal Reserve Board to purchase municipal bonds issued in response to the COVID-19 (i.e., coronavirus disease 2019) emergency and otherwise modifies the terms under which the board may generally purchase municipal bonds.

#### Title

To permit, due to the COVID-19 emergency, Federal financial regulators to allow for the temporary waiver of requirements that a State, territory, or local government provide matching or cost-sharing funds before receiving a grant from a Federal financial regulator, to allow for certain reprogramming of funds to support unemployment, childcare, and healthcare programs, and for other purposes.

#### Description

This bill temporarily allows financial regulators to waive cost-sharing and program requirements for certain state, territory, and local government grants. Financial regulators may permit these funds to be reprogrammed for purposes related to unemployment, childcare, or healthcare.

#### Title

Coronavirus Community Relief Act

#### Description

Coronavirus Community Relief Act This bill provides \$250 billion for certain localities affected by the COVID-19 (i.e., coronavirus disease 2019) pandemic. Specifically, the bill provides funding for FY2020 for units of local government with a population of 500,000 or less. Payment shall be made within 30 days after submission of a specified certification by the locality. The amount of the payment is proportional to population. Local governments shall use the funds provided to cover only those costs that (1) are necessary and related to the public health emergency caused by COVID-19, and (2) were incurred during the period of March 1-December 30, 2020. The Office of Inspector General of the Department of the Treasury shall conduct monitoring and oversight of the receipt, disbursement, and use of funds.

FEED Act

**Description**

FEMA Empowering Essential Deliveries Act or the FEED Act This bill authorizes the Federal Emergency Management Agency (FEMA) to approve state, local, and Indian tribal government plans to partner with small and mid-size restaurants and nonprofit organizations to provide nutritious meals to individuals in need. Specifically, during the period following the President's emergency declaration of March 13, 2020, and under any subsequent major disaster declaration that supersedes it, FEMA may approve plans from state, local, and Indian tribal governments that (1) establish contracts with small and mid-sized restaurants and nonprofits, including faith-based organizations and soup kitchens, to prepare healthy meals for people in need; and (2) provide for partnerships with nonprofit organizations to purchase directly from food producers and farmers. FEMA shall waive federal matching requirements under the Robert T. Stafford Disaster Relief and Emergency Assistance Act during such period.

Coronavirus State and Local Financial Assistance Act

**Description**  
Coronavirus State and Local Financial Assistance Act This bill (1) directs the Department of the Treasury to establish a State and Local Government Coronavirus Relief Program under which Treasury shall make monthly grants to states to make up for revenue lost from March 1-December 31, 2020, due to COVID-19 (i.e., coronavirus disease 2019) and social distancing steps taken by the state and its political subdivisions, and (2) appropriates \$500 billion to carry out the program. To be eligible to receive a grant, a state must (1) compile estimates for the revenue lost by the state and each political subdivision, and (2) submit an estimate to Treasury by the 20th of each month. Treasury shall make grant payments to a state within 15 days of receiving a loss estimate. The bill sets forth requirements with respect to pro rata distribution of funds, treatment of overpayments, and distribution to political subdivisions of a state.

#### Title

Farmers Feeding Families Coronavirus Response Act

#### Description

Farmers Feeding Families Coronavirus Response Act This bill directs the Department of Agriculture (USDA) to use specified federal funding to purchase specialty crops, dairy, meat, and poultry products from specific agricultural producers relying on markets affected by COVID-19 (i.e., coronavirus disease 2019) to provide to food assistance programs, including the Emergency Food Assistance Program. USDA must also provide additional funding to the states for the purpose of procuring food products to support food assistance programs within each state. USDA and the states must use at least 10% of the funding to purchase crops and products that would otherwise have been sold through direct-to-consumer, direct-to-institution, direct-to-retail, or direct-to-restaurant marketing channels.

#### Title

Direct Support for Communities Act

#### Description

Direct Support for Communities Act This bill provides FY2020 supplemental appropriations to the Department of Housing and Urban Development (HUD) to award additional Community Development Block Grants to units of local government and counties to prevent, prepare for, and respond to coronavirus (i.e., the virus that causes COVID-19). Specifically, within 30 days, HUD must distribute 50% of such funds to metropolitan cities and other units of local government and 50% to counties and parishes. Such funds may be used to cover costs or replace lost, delayed, or decreased revenues stemming from the COVID-19 (i.e., coronavirus disease 2019) public health emergency. In addition, the funds are designated as an emergency requirement, which exempts the funds from discretionary spending limits and other budget enforcement rules.

The Direct Support for Communities Act would provide local governments with direct federal relief that can be used to pay for essential services and offset lost revenues and increased costs from the COVID-19 emergency. This local assistance would complement critical relief that states also require in this crisis, which the representatives are simultaneously aggressively pursuing. Under the bill, the local relief fund would be split 50/50, half committed to cities, towns and villages, and half committed to counties.

#### Description

The Heroes Act This bill responds to the COVID-19 (i.e., coronavirus disease 2019) outbreak and its impact on the economy, public health, state and local governments, individuals, and businesses. Among other things, the bill \* provides FY2020 emergency supplemental appropriations to federal agencies; \* provides payments and other assistance to state, local, tribal, and territorial governments; \* provides additional direct payments of up to \$1,200 per individual; \* expands paid sick days, family and medical leave, unemployment compensation, nutrition and food assistance programs, housing assistance, and payments to farmers; \* modifies and expands the Paycheck Protection Program, which provides loans and grants to small businesses and nonprofit organizations; \* establishes a fund to award grants for employers to provide pandemic premium pay for essential workers; \* expands several tax credits and deductions; \* provides funding and establishes requirements for COVID-19 testing and contact tracing; \* eliminates cost-sharing for COVID-19 treatments; \* extends and expands the moratorium on certain evictions and foreclosures; and \* requires employers to develop and implement infectious disease exposure control plans. The bill also modifies or expands a wide range of other programs and policies, including those regarding \* Medicare and Medicaid, \* health insurance, \* broadband service, \* medical product supplies, \* immigration, \* student loans and financial aid, \* the federal workforce, \* prisons, \* veterans benefits, \* consumer protection requirements, \* the U.S. Postal Service, \* federal elections, \* aviation and railroad workers, and \* pension and retirement plans.

#### Title

To require States to certify a process for distributing Coronavirus Relief Funds to local governments.

#### Description

This bill requires states to certify a process for distributing Coronavirus Relief Funds to local governments. Specifically, each state that received such funds shall provide the Department of the Treasury, by June 12, 2020, with a certification that the state has in effect a procedure to distribute the funds to units of local government, including a detailed description of such procedure. If a state fails to comply with this requirement, 25% of such payment shall be booked as a debt owed to the federal government.

Coronavirus County Relief and Stability Act

#### Description

Coronavirus County Relief and Stability Act This bill appropriates \$36 billion for a Coronavirus County Relief Fund to make payments to counties to compensate for revenue lost and costs incurred as a result of the COVID-19 (i.e., coronavirus disease 2019) public health emergency. Specifically, a county shall use the funds to compensate for direct loss of revenue due to the public health emergency or to cover its costs that \* are necessary expenditures incurred due to the public health emergency, \* were not accounted for in the budget most recently approved as of February 29, 2020, and \* were incurred from March 1, 2020-December 30, 2020. Each county shall receive a flat payment plus an amount based on its population. The bill provides funding for the Office of Inspector General of the Department of the Treasury to conduct monitoring and oversight of the receipt, disbursement, and use of such funds. The bill reauthorizes the payments in lieu of taxes program, which compensates local governments for tax revenue lost due to tax-exempt federal lands within their boundaries.

FEMA Assistance Relief Act of 2020 This bill modifies the federal cost share of certain emergency assistance relating to COVID-19 (i.e., coronavirus disease 2019). Specifically, the bill provides for (1) a 100% federal cost share of assistance provided under the emergency declaration issued by the President on March 13, 2020, relating to COVID-19 and any subsequent major disaster declaration that supersedes it; and (2) at least a 90% federal cost share of assistance provided for any emergency or major disaster declared by the President from January 1-December 31, 2020. These provisions shall apply to funds appropriated on or after this bill's enactment. With respect to the emergency declaration issued on March 13, 2020, the President may provide assistance for activities, costs, and purchases of states, Indian tribal governments, or local governments, including, among other things \* backfill costs for first responders and other essential employees who are ill or quarantined; \* increased operating costs for essential government services due to such emergency; \* personal protective equipment and other critical supplies and services for first responders; and \* costs of procuring and distributing food to individuals affected by the pandemic. The bill (1) directs the President to provide financial assistance to meet disaster-related funeral expenses (subject to the availability of appropriations), and (2) authorizes specified assistance in advance. FEMA must enter into an agreement with the National Academy of Sciences to convene a committee of experts to study the use of certain assistance to respond to an emergency that does not cause physical damages. The bill extends by one year federal disaster assistance to individuals and households.

Keeping Schools Safe Act This bill directs the Department of Education (ED) to award competitive grants to eligible entities (i.e., local educational agencies, educational service agencies, and the Bureau of Indian Education) to improve the indoor air quality in elementary and secondary schools in response to the COVID-19 (i.e., coronavirus disease 2019) public health emergency. In addition, ED must consult with the Centers for Disease Control and Prevention and other relevant agencies and national organizations to develop technical guidance for eligible entities to address the safety and health of students and staff. ED must, within 21 days, provide eligible entities with this technical guidance. A grant recipient must use funds to improve or monitor the indoor air quality, ventilation, or circulation in schools using the technical guidance provided by ED.

Remove Impediments for a Successful Economic Recovery Act or the RISER Act This bill extends the deadline for the use of sums from the Coronavirus Relief Fund for states or local governments that use such funds to respond to the COVID-19 (i.e., coronavirus disease 2019) public health emergency in accordance with a qualifying economic development plan until December 31, 2022 (currently, funds may be used for costs incurred through December 30, 2020). The plan must be approved by the state or the governing board of a university before December 30, 2020.
