The E&C provisions include: build on the work done by the administration to strengthen the Strategic National Stockpile to better respond to COVID-19 and future public health emergencies; ensure Americans, especially seniors, can access the care they need – whether it be mental health or telehealth services; strengthen critical domestic health care supply chains; improve public health infrastructure; address COVID-19 health disparities; and double down on our efforts to fight the opioid epidemic and substance abuse disorder crises.

Description
Helping Emergency Responders Overcome Act or the HERO Act
This bill establishes a series of programs relating to the behavioral health of public-safety officers (e.g., law enforcement officers, firefighters, ambulance crew members, and 9-1-1 operators) and health care providers. For example, the bill establishes (1) a public-safety officer suicide-reporting system at the Centers for Disease Control and Prevention, (2) a grant program for peer-support behavioral health and wellness programs within fire departments and emergency medical services agencies, and (3) a grant program for behavioral health and wellness programs for health care providers.

Medicare Advantage COVID Treatment Act

Description
Medicare Advantage COVID Treatment Act This bill requires Medicare Advantage (MA) plans to cover specified treatment services relating to COVID-19 (i.e., coronavirus disease 2019) without cost-sharing during the public health emergency declared on January 31, 2020. The CMS must reimburse MA plans for cost-sharing amounts that would otherwise have been received, in accordance with a specified timeline. MA plans are also prohibited from instituting prior authorization or other utilization management requirements with respect to coverage of specified critical treatment services (e.g., ventilator services and intensive care unit services).

Lower Drug Costs for Seniors During COVID-19 Act of 2020

Description

Lower Drug Costs for Seniors During COVID-19 Act of 2020 This bill requires the Centers for Medicare & Medicaid Services to establish a process for prescription drug plans under Medicare and Medicare Advantage to allow enrollees to make coinsurance payments in periodic installments, if the enrollee chooses to obtain the entire prescribed supply of a covered drug in a single fill. Current law allows an enrollee, during the public health emergency relating to COVID-19 (i.e., coronavirus disease 2019), to obtain the entire prescribed supply of a covered drug in a single fill or refill, up to a 90-day supply.

This flexibility will be critical to help beneficiaries afford a three-month prescription and lower their out-of-pocket costs during the COVID-19 crisis, improving their lives and livelihood.

Description

Emergency COVID Telehealth Response Act This bill requires the Centers for Medicare & Medicaid Services (CMS) to allow, when exercising its waiver authority, the following providers to furnish telehealth services under Medicare during the public health emergency relating to COVID-19 (i.e., coronavirus disease 2019): physical therapists, physical therapist assistants, occupational therapists, occupational therapy assistants, speech-language pathologists, clinical social workers, and audiologists. (Currently, the CMS is authorized to waive requirements for Medicare telehealth services during the public health emergency, and it has done so to allow all providers that are otherwise eligible to furnish in-person services under Medicare to also furnish telehealth services.)

PRICE Act

Description

Pandemic Response and Interstate Cost Equity Act or the PRICE Act This bill establishes the Federal Emergency Management Agency (FEMA) as the sole buyer, vendor, owner, and distributor of certain medical equipment obtained by the federal government in the event of a national health emergency and establishes a process for the pricing and distribution of such equipment. Specifically, in the event of such an emergency, the Department of Health and Human Services shall assess available medical equipment and FEMA shall (1) become the sole owner and distributor of medical equipment obtained by the federal government for which the prevailing market price exceeds the fair market price by more than 15%, (2) contract with all persons capable of producing such equipment to produce such equipment, and (3) establish a price for such equipment and sell or otherwise distribute the equipment to the states or to persons that request it. The bill establishes in Congress a Joint Committee on Defense Production.

COVID-19 Testing, Reaching, And Contacting Everyone (TRACE) Act
This bill authorizes the Centers for Disease Control and Prevention (CDC) to award grants for testing, contact tracing, monitoring, and other activities to address COVID-19 (i.e., coronavirus disease 2019). Entities such as federally qualified health centers, nonprofit organizations, and certain hospitals and schools are eligible to receive such grants. In awarding the grants, the CDC shall prioritize applicants that (1) operate in hot spots and medically underserved communities, and (2) agree to hire individuals from the communities where grant activities occur.

Title Medicare Crisis Program Act of 2020 **Introduction Date:** 2020-05-01

Description

Medicare Crisis Program Act of 2020 This bill makes a series of changes to health insurance coverage and requirements during the public health emergency relating to COVID-19 (i.e., coronavirus disease 2019). For example, the bill makes several changes to Medicare and Medicare Advantage (MA) during the public health emergency. Among other things, the bill * allows all individuals who receive unemployment benefits, and their dependents, to enroll in Medicare if they otherwise do not have health insurance coverage; * eliminates cost-sharing for COVID-19 drugs and treatment services under Medicare and MA; * eliminates premiums under Medicare and caps overall cost-sharing under Medicare and MA; and * establishes a national clearinghouse for the purchase and distribution of COVID-19 personal protective equipment for Medicare providers. The bill also alters requirements under Medicaid and the Children's Health Insurance Program (CHIP) and for private health insurers during the emergency. Among other things, the bill * requires coverage of COVID-19 vaccines and treatment services under Medicaid and CHIP without cost-sharing; * increases the Medicaid Federal Medical Assistance Percentage (FMAP) that is otherwise applicable during the public health emergency, including for states experiencing economic downturns (i.e., high unemployment); * requires private health insurers to cover COVID-19 treatment services without cost-sharing; and * requires federal payment to health care providers for the cost of COVID-19 treatment services that are provided to uninsured individuals, based on Medicare payment rates.

Quality Care for Nursing Home Residents and Workers During COVID-19 Act of 2020

Introduction Date: 2020-05-05

Description

Quality Care for Nursing Home Residents and Workers During COVID-19 Act of 2020 This bill modifies several requirements for Medicare skilled nursing facilities (SNFs) and Medicaid nursing facilities (NFs) during the public health emergency relating to COVID-19 (i.e., coronavirus disease 2019). Specifically, SNFs and NFs must comply with specified quality of care, worker safety, and transparency requirements, subject to civil penalties. Requirements include (1) testing residents and employees for COVID-19 weekly or before shifts, respectively, and reporting any lack of available testing kits on a daily basis; (2) providing at least two weeks of paid sick leave to each employee; and (3) reporting the number of COVID-19 cases and deaths, including demographic information, on a daily basis. The Centers for Medicare & Medicaid Services must also distribute funds to allow states to establish strike teams that may be deployed to SNFs and NFs within 72 hours of three or more COVID-19 diagnoses to help separate those who have been exposed, supervise testing, and ensure enforcement of whistleblower protections, among other needs. Teams must include members of the National Guard, public health officials, medical experts, and representatives of residents and workers.

Coronavirus Frontline Workers Fair Pay Act

Description

Coronavirus Frontline Workers Fair Pay Act This bill provides hazard pay, in addition to regular pay, to specified health care and essential workers during calendar year 2020. Health care workers, which include physicians and support staff, among others, are eligible for a maximum of \$35,000 in aggregate hazard pay. Essential workers, as determined by the Cybersecurity and Infrastructure Security Agency, are eligible for a maximum of \$25,000 in aggregate hazard pay. The Department of the Treasury must make payments to employers based on an employer's quarterly projections of the number of hours worked by eligible employees, including specified hours worked prior to the enactment of this bill. Employers must issue hazard payments to eligible employees not later than 14 days after receiving such payment from Treasury. The bill establishes and provides funding for the Coronavirus Essential and High-Risk Health Care Workers Hazard Payment Fund to implement this program.

The Coronavirus Frontline Workers Fair Pay Act would provide hazard pay to health care professionals and other essential workers. The bill would establish a dedicated fund within the U.S. Treasury Department to provide the hazard pay money to employers. High-risk health care workers would receive a hazard pay increase of \$18.50 per hour, and other essential workers would receive an increase of \$13 per hour. Pay would be capped at \$35,000 and \$25,000, respectively. It would be retroactive to January 27, 2020 and would be available through the end of this year.

Medical Supply Transparency and Delivery Act

Description

Medical Supply Transparency and Delivery Act This bill provides for the procurement and distribution of equipment and supplies needed to combat COVID-19 (i.e., coronavirus disease 2019). The bill sets forth responsibilities for the National Response Coordination Center (NRCC) of the Federal Emergency Management Agency, including that the NRCC must (1) direct the national production and distribution of critical medical equipment and supplies; (2) communicate with states, local governments, and Native American tribes regarding the availability and delivery schedule of equipment and supplies; and (3) make specified information publicly available. The Department of Defense may detail members of the Armed Forces on active duty or civilian employees to support the NRCC. The President, using authorities provided under the Defense Production Act of 1950, must establish a fair and reasonable price for and procure needed equipment and supplies. The Government Accountability Office must annually submit a report to Congress assessing the Strategic National Stockpile. The Council of the Inspectors General on Integrity and Efficiency shall designate an inspector general to oversee this bill's implementation.

Title Emergency Medical Supplies Procurement Act		Bill Summary: Last edited by TFG Reports at May 11, 2020, 2:41 PM The Emergency Medical Supplies Procurement Act provides an additional \$75 billion for the Trump administration to purchase or manufacture personal protective equipment (such as surgical masks, N-95 respirator masks, surgical gowns, and face visors); ventilators; testing reagents and compounds; approved vaccines, therapeutics, diagnostics, pharmaceuticals; and any other medical supplies or hospital infrastructure that are necessary. The bill would also require the Trump administration to respond to state requests for urgent and critical health care supplies as quickly and aggressively as possible using special authorities such as the DPA, National Emergencies Act, and Stafford Act.

For example, in order to receive the increased FMAP in FY2021, a state must cover, without cost-sharing, testing and treatment for COVID-19 (i.e., coronavirus disease 2019), including vaccines, specialized equipment, and therapies.

Description

Medicare Accelerated and Advance Payments Improvement Act of 2020 This bill establishes and otherwise modifies requirements for the Medicare Accelerated and Advance Payment Program during the public health emergency relating to COVID-19 (i.e., coronavirus disease 2019). The program provides Medicare payments in advance to eligible providers experiencing claims or cash flow disruptions, such as during national emergencies; the program was specifically expanded in response to COVID-19 to encompass more types of providers, subject to certain recoupment and repayment provisions. Under the current program, recoupment of advance payments (through claims offsets) begins up to four months after the payment is made. Additionally, certain hospitals have one year to repay the full amount; other types of providers have seven months. Repayments made after this period are subject to the prevailing interest rate set by the Department of the Treasury (generally around 10% in FY2020). The bill delays recoupment for one year and caps the recoupment at 25% of a claim. The bill also gives all providers up to two years for full repayment and caps the interest rate at 1%. Additionally, the Centers for Medicare & Medicaid Services (CMS) may waive repayment entirely upon a demonstration of extreme hardship, among other factors. The bill also requires the CMS to continue to make the program available to providers of Medicare medical services for the duration of the public health emergency. (The CMS suspended the program for such providers on April 26, 2020.)

Rural Hospital Sustainability Act This bill specifically allows the Center for Medicare and Medicaid Innovation to test a model for global payments to hospitals in rural areas. In addition, the bill expressly applies federal privacy standards for the use and disclosure of personal health information by health care providers, health plans, health clearinghouses, and their business associates to contact tracing technology and its use. Current law provides an exception to these standards for personal health information used by, or disclosed to, a public health authority that is legally authorized to collect the information. The bill also prohibits the use of data derived from the contact tracing technology in legal proceedings or for immigration enforcement. The Government Accountability Office must evaluate this program within 90 days.

DOT, the Department of Homeland Security (DHS), and the Department of Health and Human Services (HHS) must each designate federal facilities for receiving, processing, and analyzing data collected and experience gained by recipients of grants under the program. DOT, DHS, and HHS must use the data collected and experience gained to (1) jointly identify technical, regulatory, or policy challenges to the integration of public health risk mitigation measures related to the public health risks created by COVID-19 in airports and on passenger aircraft; and (2) inform ongoing initiatives by the Federal Aviation Administration, the Transportation Security Administration, and the Centers for Disease Control and Prevention to develop operational standards and procedures to mitigate such public health risks.

End Transfers of Detained Immigrants Act This bill imposes requirements related to individuals in U.S. Immigration and Customs Enforcement (ICE) custody during the COVID-19 (i.e., coronavirus disease 2019) public health emergency declared by the Department of Health and Human Services. If ICE cannot ensure compliance with Centers for Disease Control and Prevention guidelines for mitigating the spread of COVID-19 (including maintaining social distancing requirements at all times) in any ICE facility, ICE shall (1) immediately review the custody of all detained individuals in that facility, and (2) release individuals found eligible for release.

The COVID-19 Vaccine Awareness Support Act would authorize necessary funding to fund a public awareness campaign on COVID19 vaccine information through the Department of Health and Human Services (HHS) and the Centers for Disease Control and Prevention. Grants would go to entities to start developing campaigns that target all Americans and that would begin no later than 30 days after a vaccine is authorized.
